BETWEEN
THE TEXAS FACILITIES COMMISSION

The Texas Facilities Commission (hereinafter referred to as “TFC”), a state agency located at 1711 San Jacinto Boulevard, Austin, Texas 78701, as Owner (as defined in UGC Section 1.28) and J. E. Dunn Construction Company (hereinafter referred to as “CMR”), a Missouri corporation, located at 901 South MoPac Expressway, Building 2, Suite 375, Austin, Texas 78746 (hereinafter referred to collectively as the “Parties”), enter into the following *Amendment No. 1 to the Construction Manager-at-Risk Contract between the Texas Facilities Commission and J.
