**AMENDMENT 2 TO ASSIGNMENT NO. 1**

**THIS AMENDMENT NO. 2 ASSIGNMENT NO. 1** (hereinafter referred to as “Amendment No. 2 to Assignment No. 1”) is entered into by and between the Texas Facilities Commission, located at 1711 San Jacinto Boulevard, Austin, Texas 78701 (hereinafter referred to as “TFC”) and Jones Lang LaSalle Americas, Inc. located at 2020 K Street NW Suite 1100, Washington, D.C., 20006 (hereinafter referred to as “Consultant”) (TFC and Consultant are hereinafter referred to individually as a “Party” or collectively as “Parties”), to amend Assignment No. 1 to the original Consultant Agreement under the terms and conditions that follow.

WHEREAS, the parties entered into that one certain *Consultant Agreement between Texas Facilities Commission and Jones Lang LaSalle Americas, Inc.* TFC Contract No. 17-099-000, and dated June 1, 2017 (hereinafter referred to as the “Agreement”); and

WHEREAS, the parties entered into Assignment No. 1 dated December 4, 2017; and

WHEREAS, the parties entered into Amendment No. 1 to Assignment No. 1 dated January 11, 2018; and

WHEREAS, changes in circumstances require a mutually desirable adjustment be made to the duration of Assignment No. 1; and

WHEREAS, the parties desire to amend certain terms to their mutual benefit to reflect the changes circumstances;

NOW THEREFORE, the parties hereby agree as follows:

1. The parties hereby agree to modify DURATION OF ASSIGNMENT, so that it reads in its entirety as follows:

“DURATION OF ASSIGNMENT. The scope of services of this Assignment No. 1 shall be completed no later than May 31, 2018, unless terminated earlier as provided in Section 2.02 of the Agreement. The schedule is subject to adjustments for possible time extension; however, any extension of time must be approved by the TFC and shall require an amendment to Assignment No. 1.”

2. This Amendment No. 2 to Assignment No. 2 shall be effective as of March 15, 2018.

3. All other terms and conditions of Assignment No. 1 not otherwise specifically amended in this Amendment No. 2 to Assignment No. 1 shall remain in full force and effect.


