AMENDMENT NO. 1 TO ASSIGNMENT NO. 3

WHEREAS, pursuant to the terms of the Agreement, the Parties entered into Assignment No. 3 dated August 23, 2018, (hereinafter referred to as “Assignment No. 3”); and

WHEREAS, the parties desire to extend the Duration of Assignment No. 3;

NOW THEREFORE, the parties hereby agree as follows:

1. The parties hereby agree to modify Duration of Assignment, by deleting, “December 30, 2018,” and replacing it with “December 31, 2019.”
2. Except as amended and supplemented by this Amendment No. 1 to Assignment No. 3, the terms and conditions of the Agreement and of Assignment No. 3 shall remain in full force and effect.
