

**AMENDMENT NO. 1
TO THE
CONTRACT FOR
INSTALLATION AND MAINTENANCE OF ACCESS CONTROL
AND SURVEILLANCE SYSTEMS
BETWEEN
THE TEXAS FACILITIES COMMISSION
AND
NETRONIX INTEGRATION, INC.**

THIS AMENDMENT NO. 1 is entered into by and between the Texas Facilities Commission (hereinafter referred to as “TFC”), a state agency located at 1711 San Jacinto Boulevard, Austin, Texas 78701 and Netronix Integration, Inc. (hereinafter referred to as “Contractor”), located at 800 Paloma Drive, Suite 110, Round Rock, Texas 78665, to amend the original Contract between the parties (hereinafter referred to as the “Contract”).

WHEREAS, on October 21, 2019, the parties entered into that one certain *Services Contract for Installation and Maintenance of Access Control and Surveillance Systems Between the Texas Facilities Commission and Netronix Integration, Inc.*; and

WHEREAS, the parties have agreed that additional funding is required for on-going and anticipated cost recovery projects and for anticipated security system conversions;

NOW, THEREFORE, the parties agree to amend the Contract as follows:

1. The parties hereby agree to amend ARTICLE III – CONSIDERATION, Section 3.01 (a), Contract Limit and Fees and Expenses, to reflect an increase in the amount to be paid to the Contractor of Four Hundred Fifty Thousand and No/100 Dollars (\$450,000.00) in order to provide the services required to fulfill the terms of this Contract. Section 3.01 (a) is therefore, deleted in its entirety and replaced with Section 3.01 (a), as follows:

“3.01. **CONTRACT LIMIT AND FEES AND EXPENSES.** (a) The total amount of this Contract shall not exceed the sum of One Million Four Hundred Fifty Thousand and No/100 Dollars (\$1,450,000.00). Pricing fees will be invoiced in accordance with Exhibit B - Compensation and Fees, attached hereto and incorporated herein for all purposes. Any changes to the not-to-exceed amount of this Contract or pricing fees set forth in Exhibit B - Compensation and Fees shall be submitted to TFC for review and shall be approved by amendment to this Contract.”
