**AMENDMENT NO. 1 TO ASSIGNMENT NO. 1**

**This Indefinite Delivery Indefinite Quantity Amendment No. 1 to Assignment No. 1** (hereinafter referred to as “Amendment No. 1 to Assignment No. 1”) is entered into by and between the Texas Facilities Commission (hereinafter referred to as “TFC”), a state agency located at 1711 San Jacinto Boulevard, Austin, Texas 78701, and Parkhill, Smith and Cooper, Inc., located at 12301-B Riata Trace Parkway, Suite 100, Austin, Texas 78727 (hereinafter referred to as “PSP”) (TFC and PSP are hereinafter referred to individually as a “Party” or collectively as “Parties”), to be effective on the Effective Date (as indicated below) and to be performed in accordance with the terms and conditions that follow.

**RECITALS.**

WHEREAS, on January 24, 2018, the Parties entered into that one certain *Indefinite Delivery Indefinite Quantity Professional Services Agreement*, TFC Contract No. 18-132-000 (hereinafter referred to as the “Agreement”); and

WHEREAS, on October 30, 2018, pursuant to the terms of the Agreement, the Parties entered into Assignment No. 1 to provide engineering services for the demolition of the GJ Sutton State Office Building located at 321 Center Street, San Antonio, Texas (hereinafter referred to as “Assignment No. 1”); and

WHEREAS, on April 4, 2019, the Parties exercised the Agreement’s option to renew TFC IDIQ Contract No. 18-132-000 so that the Agreement terminates August 31, 2021; and

WHEREAS, the Parties now desire to extend the Duration of Assignment No. 1;

NOW THEREFORE, the parties hereby agree as follows:

1. The parties hereby agree to modify Duration of Assignment No. 1 by deleting the date, “December 31, 2019,” and replacing it with “April 1, 2020.”
2. Except as amended and supplemented by the Agreement’s Amendment No. 1 and this Amendment No. 1 to Assignment No. 1, the terms and conditions of the Agreement and of Assignment No. 1 shall remain in full force and effect.
