

**AMENDMENT NO. 3
TO THE
INDEFINITE DELIVERY INDEFINITE QUANTITY
PROFESSIONAL SERVICES AGREEMENT
BETWEEN
THE TEXAS FACILITIES COMMISSION
AND
TAB TECHNOLOGIES, LLC**

THIS AMENDMENT NO. 3 is entered into by and between the Texas Facilities Commission (hereinafter referred to as “TFC”), a state agency located at 1711 San Jacinto Boulevard, Austin, Texas 78701 and TAB Technologies, located at 5321 Industrial Oaks Boulevard, Suite 124, Austin, Texas 78735 (hereinafter referred to as “PSP”) (hereinafter collectively referred to as the “Parties”) to amend the original Indefinite Delivery Indefinite Quantity Professional Services Agreement, as amended (hereinafter referred to as the “Agreement”).

WHEREAS, on June 12, 2017, the Texas Facilities Commission (hereinafter, the “Commission”) authorized the award of certain Indefinite Delivery Indefinite Quantity Professional Services Agreements (hereinafter referred to as “IDIQ Agreements”) pursuant to Commission Policy Article III (b) regarding IDIQ Agreements; and

WHEREAS, on November 7, 2017, the Parties entered into that one certain *Indefinite Delivery Indefinite Quantity Professional Services Agreement*, TFC Contract No. 18-112-000; and

WHEREAS, on April 4, 2019, the Parties executed Amendment No. 1 for the purpose of renewing the Agreement for a two (2) year period commencing on September 1, 2019 and ending on August 31, 2021; and

WHEREAS, May 7, 2019, the Parties executed Amendment No. 2 for the purpose of modifying Section 10.1.1.1, an insurance provision, of the Agreement; and

WHEREAS, the Parties now desire to amend the Agreement, as amended, for the purpose of changing the PSP address;

NOW, THEREFORE, the Parties agree to amend the Agreement by replacing all references to PSP’s address in the Agreement and its Amendments 1 and 2, to: “5321 Industrial Oaks Boulevard, Suite 124, Austin, Texas 78735.”
