

**AMENDMENT NO. 3
TO THE
INTERAGENCY COOPERATION CONTRACT
BETWEEN
TEXAS FACILITIES COMMISSION
AND
TEXAS A&M UNIVERSITY – CORPUS CHRISTI**

This Amendment No. 3 to the Interagency Cooperation Contract (Contract) is entered into by and between the Texas Facilities Commission (TFC) and Texas A&M University – Corpus Christi (TAMUCC), to amend the original Contract between the parties effective October 1, 2015 (hereinafter referred to as the “Contract”).

WHEREAS, changes in circumstances require mutually desirable alterations in the fees and term of the Contract; and

WHEREAS, the parties desire to amend certain terms to their mutual benefit to reflect the changed circumstances; and

WHEREAS, the parties have agreed that One Hundred Twenty Two Thousand Nine Hundred Fifty Four and 90/100 Dollars (\$122,954.90) to be added to Contract amount is needed to extend the Contract from September 1, 2017 to January 31, 2018;

NOW, THEREFORE, the parties agree to amend the Contract as follows:

1. The parties hereby agree to modify ARTICLE III – CONSIDERATION, SECTION 3.01 – CONTRACT AMOUNT by increasing the amount of fees to be paid under this Contract by One Hundred Twenty Two Thousand Nine Hundred Fifty Four and 90/100 Dollars (\$122,954.90), thus increasing the total not to exceed amount of the Contract from Five Hundred Eighty Four Thousand Nine Hundred Forty and 79/100 Dollars (\$584,940.79) to Seven Hundred Seven Thousand Eight Hundred Ninety Five and 69/100 Dollars (\$707,895.69).
2. Additionally, the parties hereby agree to modify ARTICLE V – TERM OF CONTRACT, SECTION 5.01 – TERM by deleting the paragraph in its entirety and substituting it with the following:

“This Contract shall be effective as of October 1, 2015 and shall expire on January 31, 2018, unless extended by the parties by amendment to this Contract or terminated earlier, as provided in Section 5.03 set forth below.”

Except as expressly amended above, the Contract remains in full force and effect.
