**AMENDMENT NO. 2
TO THE
CONTRACT
FOR
VIDEO PRODUCTION AND STREAMING SERVICES
BETWEEN
THE TEXAS FACILITIES COMMISSION
AND
TEXASADMIN.COM, A WHOLLY OWNED SUBSIDIARY OF
ADMINMONITOR, INC.**

This Amendment No. 2 is entered into by and between the Texas Facilities Commission (hereinafter referred to as "TFC"), a state agency located at 1711 San Jacinto Boulevard, Austin, Texas 78701 and Texasadmin.com, Inc., A Wholly Owned Subsidiary of Adminmonitor, Inc. located at 2550 South IH 35, Suite 205, Austin, Texas 78704 (hereinafter referred to as "Contractor") (hereinafter collectively referred to as the "Parties"), to amend the original contract, as amended, for video production and streaming services for public meetings held by TFC (hereinafter referred to as the "Contract").

WHEREAS, on July 12, 2018, the Parties entered into that one certain *Contract for Video Production and Streaming Services between the Texas Facilities Commission and Texasadmin.com, a wholly owned subsidiary of Adminmonitor, Inc.*; and

WHEREAS, on August 19, 2019, the Parties executed Amendment No. 1 extending the Contract through October 31, 2019, providing for funding during the months of September and October 2019, and including additional provisions, terms and conditions adopted subsequent to the execution of the Contract; and

WHEREAS, pursuant to Sections 2.1, Contract Award, 3.1, Contract Limit Fees and Expenses, and 10.28, Entire Contract and Modification, the Parties now desire to further extend the Contract and provide for additional funding during the extended Term;

NOW THEREFORE, the Parties agree to amend the Contract, as follows:

1. The Parties agree to that this Amendment No. 2 shall be effective as of November 1, 2019.
2. The Parties agree to modify ARTICLE II – TERM, Section 2.1, Contract Award, Subsection (a) by deleting Section 2.1 (a) in its entirety and replacing it with Section 2.1 (a), as follows:

“2.1. **CONTRACT AWARD.** (a) This Contract shall be effective as of the date of the last party to sign and shall expire on August 31, 2021, unless extended by the parties by amendment to this Contract or terminated earlier, as provided in Section 2.3 below. This Contract may be

renewed for one (1) additional period of twenty-two (22) months, and one (1) additional period of two (2) years. Any extension(s) or renewal(s) shall be at the same terms and conditions, plus any approved changes.”

3. The Parties agree to modify ARTICLE III – CONSIDERATION, Section 3.1 (a), Contract Limit and Fees and Expenses, to reflect an increase in the total amount of the Contract of One Hundred Five Thousand Three Hundred Six and 66/100 Dollars (\$105,306.66). Section 3.1 (a) is therefore deleted in its entirety and replaced with Section 3.1 (a), as follows:

“3.1. **CONTRACT LIMIT AND FEES AND EXPENSES.** (a) The total amount of this Contract shall not exceed the sum of Two Hundred Twelve Thousand Six Hundred Twenty-Four and 00/100 Dollars (\$212,624.00). Pricing fees will be invoiced in accordance with Exhibit A-1 – Pricing Schedule- Renewal, incorporated under Contract Amendment No. 1 for all purposes. Any changes to the not-to-exceed amount or pricing fees set forth in Exhibit A-1 – Pricing Schedule - Renewal shall be submitted to TFC for review and shall be approved by amendment to this Contract.”

Except as expressly amended above, all provisions, terms and conditions of the Contract, as amended, remain in full force and effect.
