

**AMENDMENT NO. 1
TO THE CONTRACT
FOR
UNIFORM RENTAL SERVICES
BETWEEN
THE TEXAS FACILITIES COMMISSION
AND
UNIFIRST CORPORATION**

THIS AMENDMENT NO. 1 is entered into by and between the Texas Facilities Commission (hereinafter referred to as “TFC”), a state agency located at 1711 San Jacinto Boulevard, Austin, Texas 78701 and Unifirst Corporation (hereinafter referred to as “Contractor”), located at 6000 Bolm Road, Austin, Texas 78721, to amend the original Contract, between the parties (hereinafter referred to as the “Contract”).

WHEREAS, on February 28, the Parties entered into that one certain *Uniform Rental Services Contract Between The Texas Facilities Commission and Unifirst Corporation* known at TFC Contract No. 17-044-000; and

WHEREAS, the Parties now agree to reconcile the date parameters for the original term of the Contract and correct the funding for the resulting corrected original term; and

WHEREAS, the Parties agree to amend certain terms to their mutual benefit to reflect these changed circumstances;

NOW, THEREFORE, the parties agree to amend the Contract as follows:

1. The parties hereby agree to modify ARTICLE II– TERM, SECTION 2.1(a) – CONTRACT AWARD, so that it reads in its entirety, as follows:

“CONTRACT AWARD. (a.) This Contract shall be effective as of March 1, 2017 and shall expire on August 31, 2018, unless extended by the parties by amendment to this Contract or terminated earlier, as provided in Section 2.2 set forth below. This Contract may be renewed for an additional two (2), two (2) year periods, provided that renewal is in the form of a new contract document executed by both parties prior to expiration of the current contract term.

2. The Parties further agree to modify ARTICLE III – CONSIDERATION, SECTION 3.1(a) - CONTRACT LIMIT AND FEES AND EXPENSES so that it reads in its entirety as follows:

“CONTRACT LIMIT AND FEES AND EXPENSES. (a.) The total amount of fees to be paid under this Contract shall not exceed the sum of One Hundred Thirty Six Thousand and No/100 Dollars (\$136,000.00). This amount includes the Fiscal Year 2017 contract base fee of Forty Five Thousand Three Hundred Thirty Three and 30/100 Dollars (\$45,333.30), and the Fiscal Year 2018 contract base fee of Ninety Thousand Six Hundred Sixty Six and 70/100 Dollars (\$90,666.70). Pricing fees shall be invoiced in accordance with Exhibit B – Compensation and Fees, attached hereto and incorporated

herein for all purposes. Any changes to the fees set forth in Exhibit B – Compensation and Fees shall be submitted to TFC for review and shall be approved by amendment to this Contract.”


Except as expressly amended above, all provisions of the Contract remain in full force and effect.
