#	QUESTION	ANSWER
1	Lines 154 and 165 on your spread sheet show cogged belts. I can't find a cogged belt in those sized. Can you check and be sure that they are cogged and not regular belts please? An A97 and B148 exist but not at AX97 or BX148.	Line item 154 is correct with AX97. We have purchased this size in both Goodyear and Bando in the past. Line item 165 should be 6B148 which is already included as Line item 99. Line item 165 has been removed in the revised <u>Attachment B - Pricing Sheet Addendum 1</u> .
2	Can you send a bid tabulation for past awards of IFB 303-8-01315 Blanket PO for V-Belts?	This is the first time we have put these items out for bid. There are no previous award or tabulation data available.
3	Which brand/mfg. would you prefer and/or what are you currently using?	We are currently using Bando or Goodyear belts. Our preference is for any reliable, durable, long lasting belts.
4	Can you please forward a copy of the last award along with the last Solicitation?	See answer to Question #2 above.
5	Line no. 165 says "6bx148". I assume that means a 6 banded BX148 belt. I can not find a manufacturer that makes that size banded belt. The closest I could find is a 6 banded BX144. Can you see if this was a typo? If not can you tell me the Mfg. for the 6bx148?	See answer to Question #1 above.
