Minutes No. 127: Minutes of the October 21, 2021, Public Meeting of the Texas Facilities Commission in Austin, Travis County, Texas.

After providing notice as required by the Texas Open Meetings Act, the Texas Facilities Commission held an open meeting at the Central Services Building, 1711 San Jacinto Boulevard, in Conference Room 402, Austin, Texas, on Thursday October 21, 2021, commencing at 9:00 a.m. Chairman Alvis called the meeting to order, Commissioners Jones, Wagner, and Allensworth were present and participated in person for the entirety of the meeting. Commissioner Betancourt participated virtually. Commissioner Bailey was absent for this meeting.
