JOB SUMMARY:

Performs advanced (senior-level) restoration, renovation, and maintenance work. Work involves building repair, renovation, restoration, and alteration for the designated trade skill. Works under minimal supervision with extensive latitude for the use of initiative and independent judgment.

ESSENTIAL FUNCTIONS:

- Plans, schedules, or oversees building repair, renovation, or restoration projects.
- Performs construction, maintenance, and/or repair work such as electrical, plumbing, steam, air conditioning, mechanical, powerhouse and water treatment equipment, and modular furniture systems.
- Performs carpentry work such as the installation, alteration, repair, and maintenance of buildings, doors, windows, wood fixtures, and furniture.
- Performs gas and electric work such as welding, brazing, and soldering on ferrous and non-ferrous metals to repair, maintain, or fabricate parts and equipment.
- Maintains and repairs electrical outlets, control panels, switches, fixtures and accessories; and splices wires and cables.
- Performs inspections of equipment, operating machinery, systems and buildings accessories and appliances to ensure proper maintenance and repair.
- Provides timely responses to requests and complies with the Uniform Building Code, Texas Accessibility Act.
- Calculates material and labor costs and orders parts and supplies to complete work orders.
- Requisitions supplies and equipment and maintains maintenance records.
- Reads and interprets plans and blueprints.
- Operates a State motor vehicle to perform some essential functions.
- Acts as lead worker on construction, maintenance, or repair projects; test repairs.
- Trains others.
- May supervise others.
- Performs related work as assigned.
- Maintains confidentiality in the handling of sensitive information.
- Serves as subject matter expert and division liaison in areas of programmatic responsibility.
- Provides excellent customer service.
- May assign codes; enters, retrieves and updates personnel information in automated human resources information systems.
- Performs other related duties as assigned.

MINIMUM QUALIFICATIONS:

- Graduation from a standard senior high school or completion of GED.
- Four (4) years experience in building maintenance and repair, including one (1) year supervisory or lead worker experience.

If selected for interview, all veterans must provide a DD214 long form. Official transcripts or other minimum requirement validations will be requested at the time of interview.

As part of its employment process, TFC may procure or have prepared a criminal background check. An applicant with an unsatisfactory criminal background check report is ineligible to be hired for the position for which the report is initiated.

Driver's record check will be conducted by the agency. Satisfactory driving records are required for driving state or personal vehicles and motor driven equipment to conduct agency business. CDL "Drivers" must consent to TFC's Drug and Alcohol Testing Policy against the illegal use of alcohol and drugs.

If hired, employee must provide document(s) within three (3) days of hire date that establish identity and employment eligibility. A complete list of acceptable documents is on file with the local Texas Workforce Commission office.
