This position will perform highly complex computer programming work. Work involves developing and maintaining applications and interfaces between 3<sup>rd</sup> party applications and between internal and 3<sup>rd</sup> party applications; Maintaining and developing solutions to enable information sharing and management between business groups and disparate processes and systems; Development and maintenance of various database systems; Ensure the coordination and integration of systems design in accordance with IT policies, procedures and operations; and developing processes for migrating data from legacy systems to new ones.

Standardizing and cleaning data, building prediction models, outcomes, and develop metrics for analytic reporting. Works with variety of tools- Power BI, tableau or Qlik to extract data and develop logic, reports and analyze data sets.

#### **Conditions of Employment:**

Initial screening is based on the Education and Experience minimum qualifications defined in the job posting.
