**AMENDMENT NO. 2
TO
CONSTRUCTION MANAGER-AT-RISK CONTRACT
BETWEEN
THE TEXAS FACILITIES COMMISSION
AND
J. E. DUNN CONSTRUCTION COMPANY**

The Texas Facilities Commission (hereinafter referred to as “TFC”), a state agency located at 1711 San Jacinto Boulevard, Austin, Texas 78701, as Owner (as defined in UGC Section 1.28) and J. E. Dunn Construction Company (hereinafter referred to as “CMR”), a Missouri corporation, located at 1601 South MoPac Expressway, Barton Skyway 2, Suite 450, Austin, Texas 78746 (hereinafter referred to collectively as the “Parties”), enter into the following *Amendment No. 2 to the Construction Manager-at-Risk Contract between the Texas Facilities Commission and J. E. Dunn Construction Company* (hereinafter referred to as the “Amendment No. 2”).

Recitals:

WHEREAS, on or about September 4, 2018, the Parties entered into that one certain *Construction Manager-at-Risk Contract Between the Texas Facilities Commission and J. E. Dunn Construction Company* (hereinafter referred to as the “Contract”); and

WHEREAS, on May 24, 2019, the Parties executed Amendment No. 1 changing the Contractor’s address; and

WHEREAS, subject to Contract Sections 2.2.7, TFC Approvals, 12.8, Notices, and 12.27, Entire Agreement and Modification, the Parties now desire to amend the Contract to change the Contractor’s address;

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

1. Unless clearly provided otherwise herein, all terms and phrases in initial capital letters herein shall have the same meaning as the terms and phrases with initial capital letters in the Contract.

2. All references in the Contract to CMR’s address other than as amended herein shall be amended as follows.

2.1. The Parties agree to amend the Contract by deleting any address given in the Contract for the CMR and replacing it with the following address.

“1601 South Mopac Expressway, Barton Skyway 2, Suite 450, Austin, Texas 78746.”

3. More specifically, the Parties hereby agree to amend ARTICLE XII – MISCELLANEOUS


